

WORKSHOP MEETING –August 3, 2016

The Town Council of the Borough of Conway met in Workshop Session on Wednesday, August 3, 2016 at 7:00 P.M., in the Fire Department Banquet Hall, South Gross Street, for the purpose of transacting General Business. Vice-President Sobolosky presided and opened the meeting with the pledge to the flag.

Mr. Giles distributed a copy of his July 2016 Public Works Report to Council. He read the report.

EMA COORDINATOR’S REPORT: *Robert Skocich*

Mr. Skocich had nothing to report.

FIRE CHIEF’S REPORT: *Robert Charlovich, Chief*

Chief Charlovich was absent from the meeting.

AGENDA ITEMS:

-Mr. Bohach stated that the bills were fine and could be placed on the Regular Meetings Agenda for approval.

-A quote for the Borough’s Property and Workers Compensation Insurance was received. The quote is from Selective Insurance Company which is currently the Borough’s carrier. The Property Insurance quote is for \$ 50,729 which is only an increase of \$179 from last year and the Workers Compensation Insurance quote is for \$60,022 which is down \$ 14,099 from last year.

A motion was made by Skocich seconded by Trombetta and carried to accept the quote from Selective Insurance Company for the Borough’s Property and Workers Compensation Insurance and a total cost of \$ 110,751.

-Community Day is this Saturday, August 6th. The Public Works Department employees usually come out on this day and work. The Secretary just needed Council to approve this and let her know how they are to be paid. Mr. Skocich asked how they were paid in the past. Mr. Giles said that they were usually given comp time at time and a half.

A motion was made by Skocich seconded by Trombetta and carried to give the Public Works employees who work on Community Day comp time at time and a half for hours worked.

-A meeting is being scheduled with DEP, Norfolk Southern and the Borough to discuss the sewer service provided to them. There will need to be representatives from Council there. It was decided that the Public Works committee should be the ones in attendance. Once it is decided on a day and time we will see who can attend and make sure that the Borough has three Council members present.

A motion was made by Trombetta seconded by Skocich and carried to adjourn at 7:15 pm.
